James D. Crawford is a very skilled and distinguished appellate litigator. A partner in the Philadelphia law firm of Schnader, Harrison, Segal & Lewis, Mr. Crawford is primarily responsible for the firm's appellate litigation. He argued Cuyler v. Adams, 449 U.S. 433 (1981) and will be arguing Davidson v. Cannon in the United States Supreme Court this coming November. A member of numerous Bar and Civic associations, Mr. Crawford also runs a Pennsylvania Law Institute on Federal Appellate Advocacy and has addressed the Pennsylvania Bar Institute on appellate advocacy.

Mr. Crawford was born in Philadelphia in 1932. He received a Bachelor of Arts degree from Haverford College in 1954, and went on to serve in the United States Army. He graduated Order of the Coif from the University of Pennsylvania Law School in 1962, serving as Editorin-Chief of the Law Review. Before joining Schnader, Harrison, Segal & Lewis in 1974, Mr. Crawford worked for Montgomery, McCracken, Walker and Rhoads, and the Office of the District Attorney of Philadelphia.
