READER'S GUIDE TO THE *PENNSYLVANIA BULLETIN* **AND PENNSYLVANIA CODE**

Pennsylvania Bulletin

The *Pennsylvania Bulletin* is the official gazette of the Commonwealth of Pennsylvania. It is published every week and includes a table of contents. A cumulative subject matter index is published quarterly.

The *Pennsylvania Bulletin* serves several purposes. First, it is the temporary supplement to the *Pennsylvania Code*, which is the official codification of agency rules and regulations and other statutorily authorized documents. Changes in the codified text, whether by adoption, amendment, repeal or emergency action must be published in the *Pennsylvania Bulletin*. Further, agencies proposing changes to the codified text do so in the *Pennsylvania Bulletin*.

Second, the *Pennsylvania Bulletin* also publishes: Governor's Executive Orders; State Contract Notices; Summaries of Enacted Statutes; Statewide and Local Court Rules; Attorney General Opinions; Motor Carrier Applications before the Public Utility Commission; Applications and Actions before the Department of Environmental Protection; Orders of the Independent Regulatory Review Commission; and other documents authorized by law.

The text of certain documents published in the *Pennsylvania Bulletin* is the only valid and enforceable text. Courts are required to take judicial notice of the *Pennsylvania Bulletin*.

Adoption, Amendment or Repeal of Regulations

Generally an agency wishing to adopt, amend or repeal regulations must first publish in the *Pennsylvania Bulletin* a Notice of Proposed Rulemaking. There are limited instances where the agency may omit the proposal step; they still must publish the adopted version.

The Notice of Proposed Rulemaking contains the full text of the change, the agency contact person, a fiscal note required by law and background for the action.

The agency then allows sufficient time for public comment before taking final action. An adopted proposal must be published in the *Pennsylvania* *Bulletin* before it can take effect. If the agency wishes to adopt changes to the Notice of Proposed Rulemaking to enlarge the scope, they must repropose.

Citation to the Pennsylvania Bulletin

Cite material in the *Pennsylvania Bulletin* by volume number and page number. Example: Volume 1, *Pennsylvania Bulletin*, page 801 (short form: 1 Pa.B. 801).

Pennsylvania Code

The *Pennsylvania Code* is the official codification of rules and regulations issued by Commonwealth agencies and other statutorily authorized documents. The *Pennsylvania Bulletin* is the temporary supplement to the *Pennsylvania Code*, printing changes as soon as they occur. These changes are then permanently codified by the *Pennsylvania Code Reporter*, a monthly, loose-leaf supplement.

The *Pennsylvania Code* is cited by title number and section number. Example: Title 10 *Pennsylvania Code*, § 1.1 (short form: 10 Pa.Code § 1.1).

Under the *Pennsylvania Code* codification system, each regulation is assigned a unique number by title and section. Titles roughly parallel the organization of Commonwealth government. Title 1 *Pennsylvania Code* lists every agency and its corresponding *Code* title location.

How to Find Documents

Search for your area of interest in the *Pennsylvania Code*.

The *Pennsylvania Code* contains, as Finding Aids, subject indexes for the complete *Code* and for each individual title, a list of Statutes Used As Authority for Adopting Rules and a list of annotated cases. Source Notes give you the history of the documents. To see if there have been recent changes, not yet codified, check the List of *Pennsylvania Code* Chapters Affected in the most recent issue of the *Pennsylvania Bulletin*.

The *Pennsylvania Bulletin* also publishes a quarterly List of Pennsylvania Code Sections Affected which lists the regulations in numerical order, followed by the citation to the *Pennsylvania Bulletin* in which the change occurred.

Printing Format

Material proposed to be added to an existing rule or regulation is printed in **bold face** and material proposed to be deleted from such a rule or regulation is enclosed in brackets [] and printed in **bold face**. Asterisks indicate ellipsis of *Pennsylvania Code* text retained without change. Proposed new or additional regulations are printed in ordinary style face.

Fiscal Notes

Section 612 of The Administrative Code of 1929 (71 P. S. § 232) requires that the Office of Budget prepare a fiscal note for regulatory actions and administrative procedures of the administrative departments, boards, commissions or authorities receiving money from the State Treasury stating whether the proposed action or procedure causes a loss of revenue or an increase in the cost of programs for the Commonwealth or its political subdivisions; that the fiscal note be published in the *Pennsylvania Bulletin* at the same time as the proposed change is advertised; and that the fiscal note shall provide the following information: (1) the designation of the fund out of which the appropriation providing for expenditures under the action or procedure shall be made; (2) the probable cost for the fiscal year the program is implemented; (3) projected cost estimate of the program for each of the five succeeding fiscal years; (4) fiscal history of the program for which expenditures are to be made; (5) probable loss of revenue for the fiscal year of its implementation; (6) projected loss of revenue from the program for each of the five succeeding fiscal years; (7) line item, if any, of the General Appropriation Act or other appropriation act out of which expenditures or losses of Commonwealth funds shall occur as a result of the action or procedures; (8) recommendation, if any, of the Secretary of the Budget and the reasons therefor.

The required information is published in the foregoing order immediately following the proposed change to which it relates; the omission of an item indicates that the agency text of the fiscal note states that there is no information available with respect thereto. In items (3) and (6) information is set forth for the first through fifth fiscal years; in that order, following the year the program is implemented, which is stated. In item (4) information is set forth for the current and two immediately preceding years, in that order. In item (8) the recommendation, if any, made by the Secretary of Budget is published with the fiscal note. See 4 Pa. Code § 7.231 *et seq.* Where "no fiscal impact" is published, the statement means no additional cost or revenue loss to the Commonwealth or its local political subdivision is intended.

Reproduction, Dissemination or Publication of Information

Third parties may not take information from the *Pennsylvania Code* and *Pennsylvania Bulletin* and reproduce, disseminate or publish such information except as provided by 1 Pa. Code § 3.44. 1 Pa. Code § 3.44 reads as follows:

§ 3.44. General permission to reproduce content of Code and Bulletin.

Information published under this part, which information includes, but is not limited to, cross references, tables of cases, notes of decisions, tables of contents, indexes, source notes, authority notes, numerical lists and codification guides, other than the actual text of rules or regulations may be reproduced only with the written consent of the Bureau. The information which appears on the same leaf with the text of a rule or regulation, however, may be incidentally reproduced in connection with the reproduction of the rule or regulation, if the reproduction is for the private use of a subscriber and not for resale. There are no other restrictions on the reproduction of information published under this part, and the Commonwealth hereby consents to a reproduction.

Title 237—JUVENILE RULES

PART I. RULES

[237 PA. CODE CHS. 3 AND 8]

Proposed Modifications to Rules 312 and 800

The Juvenile Court Procedural Rules Committee is planning to recommend to the Supreme Court of Pennsylvania that the modification of Rules 312 and 800 be adopted and prescribed. The proposed modified Rule 312 clarifies that informal adjustments may only occur prior to the filing of a petition. This proposal has not been submitted for review by the Supreme Court of Pennsylvania.

The following explanatory Report highlights the intent of this rule. Note that the Committee's Reports should not be confused with the official Committee Comments to the rules. Also note that the Supreme Court does not adopt the Committee's Comments or the contents of the Explanatory Reports.

Rule 312. Informal Adjustment.

A. *Participation*. At any time prior to the filing of a petition, the juvenile probation officer may informally adjust the allegation(s) if it appears:

1) an adjudication would not be in the best interest of the public and the juvenile;

2) the juvenile and the juvenile's guardian consent to informal adjustment with knowledge that consent is not obligatory; and 3) the admitted facts bring the case within the jurisdiction of the court.

B. Completion.

1) If the juvenile successfully completes the informal adjustment, the case shall be dismissed and prosecution is barred.

2) If the juvenile does not successfully complete the informal adjustment, a petition shall be filed.

Comment

[Informal] Pursuant to paragraph (A), informal adjustments may not occur after the filing of a petition. See Rule 800(12), which suspends 42 Pa.C.S. § 6323(a) only to the extent that it conflicts with this rule. See also Commonwealth v. J.H.B., 760 A.2d 27 (Pa. Super. Ct. 2000). [See 42 Pa.C.S. § 6323(a).]

In Com. v. C.L., 938 A.2d. 489 (Pa. Super. Ct. 2008), the Superior Court in *dictum* discusses whether informal adjustments may occur after the filing of the petition. Permitting an informal adjustment after the filing of a petition is inconsistent with this rule; therefore, *Com. v. C.L., supra*, is of no precedential value on this issue and is superseded by the suspension of 42 Pa.C.S. § 6323(a)(2) in Rule 800(12).

The juvenile probation officer or other agencies may give "counsel and advice" as to the informal adjustment. *See* 42 Pa.C.S. § 6323(b). "Counsel and advice" may include referral to a social service agency or other conditions as agreed to by the juvenile probation officer and the juvenile.

A juvenile's participation in an informal adjustment may not exceed six months, unless extended by order of the court for an additional period not to exceed three months. See 42 Pa.C.S. § 6323(c). Any incriminating statements made by the juvenile to the juvenile probation officer and in the discussions or conferences incident thereto are not to be used against the juvenile over objection in any criminal proceeding or hearing under the Juvenile Act. See 42 Pa.C.S. § 6323(e).

Prior to informally adjusting the written allegation, the juvenile probation officer is to give the victim an opportunity to comment. In addition, the victim is to be notified of the final outcome of the hearing. *See* Victim's Bill of Rights, 18 P. S. § 11.201 *et seq.*

If a petition is filed because the juvenile has not successfully completed the requirements of an informal adjustment, the procedures of Rule 330 are to be followed.

CHAPTER 8. SUSPENSIONS

Rule 800. Suspensions of Acts of Assembly.

This rule provides for the suspension of the following Acts of Assembly that apply to delinquency proceedings only: 1) The Act of November 21, 1990, P. L. 588, No. 138, § 1, 42 Pa.C.S. § 8934, which authorizes the sealing of search warrant affidavits, and which is implemented by Pa.R.Crim.P. Rule 211, through Pa.R.J.C.P. Rule 105 is suspended only insofar as the Act is inconsistent with Pa.R.Crim.P. Rules 205, 206 and 211.

2) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6335(c), which provides for the issuance of arrest warrants if the juvenile may abscond or may not attend or be brought to a hearing, is suspended only insofar as the Act is inconsistent with Rules 124 and 140, which requires a summoned person to fail to appear and the court to find that sufficient notice was given.

3) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6336(c), which provides that if a proceeding is not recorded, full minutes shall be kept by the court, is suspended only insofar as the Act is inconsistent with Rule 127(A), which requires all proceedings to be recorded, except for detention hearings.

4) The Public Defender Act, Act of December 2, 1968, P. L. 1144, No. 358, § 1 *et seq.* as amended through Act of December 10, 1974, P. L. 830, No. 277, § 1, 16 P. S. 9960.1 *et seq.*, which requires the Public Defender to represent all juveniles who for lack of sufficient funds are unable to employ counsel is suspended only insofar as the Act is inconsistent with Rules 150 and 151, which requires separate counsel if there is a conflict of interest.

5) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6337, which provides that counsel must be provided unless the guardian is present and waives counsel for the juvenile, is suspended only insofar as the Act is inconsistent with Rule 152, which does not allow a guardian to waive the juvenile's right to counsel.

6) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6305(b), which provides that the court may direct hearings in any case or class or cases be conducted by the master, is suspended only insofar as the Act is inconsistent with Rule 187, which allows masters to hear only specific classes of cases.

7) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6321, which provides for commencement of a proceeding by the filing of a petition, is suspended only insofar as the Act is inconsistent with Rule 200, which provides the submission of a written allegation shall commence a proceeding.

8) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6303(b), which provides that a district judge or judge of the minor judiciary may not detain a juvenile, is suspended only insofar as the Act is inconsistent with Rule 210, which allows Magisterial District Judges to issue an arrest warrant, which may lead to detention in limited circumstances.

9) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6334, which provides that any person may bring a petition, is suspended only insofar as the Act is inconsistent with Rules 231, 233, and 330, which provide for a person other than a law enforcement officer to submit a private written allegation to the juvenile probation office or an attorney for the Commonwealth, if elected for approval; and that only a juvenile probation officer or attorney for the Commonwealth may file a petition. 10) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6304(a)(2), which provides that probation officers may receive and examine complaints for the purposes of commencing proceedings, is suspended only insofar as the Act is inconsistent with Rules 231 and 330, which provide that the District Attorney may file a certification that requires an attorney for the Commonwealth to initially receive and approve written allegations and petitions.

11) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6331, which provides for the filing of a petition with the court within twenty four hours or the next business day of the admission of the juvenile to detention or shelter care, is suspended only insofar as the Act is inconsistent with the filing of a petition within twentyfour hours or the next business day from the detention hearing if the juvenile is detained under Rule 242.

12) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6323(a)(2), which provides that a delinquent child may be referred for an informal adjustment by a juvenile probation officer, is suspended only insofar as the Act is inconsistent with Rule 312, which provides that only an *alleged* delinquent child may be referred for an informal adjustment because the filing of informal adjustment shall occur prior to the filing of a petition.

13) Section 5720 of the Wiretapping and Electronic Surveillance Control Act, Act of October 4, 1978, P. L. 831, No. 164, 18 Pa.C.S. § 5720, is suspended as inconsistent with Rule 340 only insofar as the section may delay disclosure to a juvenile seeking discovery under Rule 340(B)(6); and Section 5721(b) of the Act, 18 Pa.C.S. § 5721(b), is suspended only insofar as the time frame for making a motion to suppress is concerned, as inconsistent with Rules 347 and 350.

[13)] 14) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6340(c), which provides consent decree shall remain in force for six months unless the child is discharged sooner by probation services with the approval of the court, is suspended only insofar as the Act is inconsistent with the requirement of Rule 373 that a motion for early discharge is to be made to the court.

[14)] 15) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6335, which provides for a hearing within ten days of the juvenile's detention unless the exceptions of (a)(1) & (2) or (f) are met, is suspended only insofar as the Act is inconsistent with Rule 391, which provides for an additional ten days of detention if a notice of intent for transfer to criminal proceedings has been filed.

[15)] 16) The Act of July 9, 1976, P. L. 586, No. 142, § 2, 42 Pa.C.S. § 6353(a), which requires dispositional review hearings to be held at least every nine months, is suspended only insofar as it is inconsistent with the requirement of Rule 610, which requires dispositional review hearings to be held at least every six months when a juvenile is removed from the home.

Comment

The authority for suspension of Acts of Assembly is granted to the Supreme Court by Article V § 10(c) of the Pennsylvania Constitution. *See* also Rule 102.

EXPLANATORY REPORT

The addition to the *Comment* of Rule 312 and the amendment of Rule 800(12) clarifies that an informal adjustment may only occur prior to the filing of a petition. An informal adjustment is a diversionary process used to dispose of the cases that should not come before the court. If a case should go to court, a petition is filed and the normal procedures of a case will follow.

As drafted, the Juvenile Act provides that a delinquent child may be referred for an informal adjustment by a juvenile probation officer. See 42 Pa.C.S. § 6323(a)(2). A child is not delinquent until there has been an adjudication of delinquency, as reiterated in *Com. v. C.L.*, 938 A.2d 489 (Pa. Super. Ct. 2008). If a child is not delinquent until after the adjudication of delinquency, then an informal adjustment would occur after that determination. However, this is not the intent of the diversionary process or an informal adjustment.

The Juvenile Act at 42 Pa.C.S. § 6323(a)(2) is being suspended to clarify that **alleged** delinquents may be referred for an informal adjustment. Once a petition is filed, informal adjustment is precluded as provided in Rule 312. Because of this suspension, the holding in *Com. v. C.L.*, supra, is superseded by the rule addition. See Rule 800(12).

And Now, this 5th day of June, 2009, in order to permit the implementation and execution of the Mortgage Foreclosure Diversion Program, it is hereby *Ordered* and *Decreed* that:

1. All Complaints for mortgage foreclosure of residential owner-occupied properties shall be accompanied by the following:

a. A Certification Cover Sheet which includes a certification that the mortgaged property is an owner-occupied residential property. (The Certification Cover Sheet is attached as Exhibit "A.")

b. An Urgent Notice, which shall be served on the Defendant along with the Complaint, directing the Defendant to contact a court-designated Hotline for assistance. (A Copy of the "Urgent Notice" is attached hereto as Exhibit "B.")

c. A Certificate of Service, in the form attached hereto as Exhibit "C."

2. Upon a request from Defendant to the Hotline for assistance and a conciliation conference, an Order for Conference shall be generated by the Court. (A sample copy of a Case Management Order is attached hereto as Exhibit "D.") The Order for Conference will be sent to all parties to the mortgage foreclosure action.

3. The entry of the Order for Conference shall include a stay of other proceedings in the case until at least 20 days following the conciliation conference.

4. As appropriate, any conciliation conference scheduled by the Court shall be conducted by judge *pro tem* designated by the Court.

5. Conciliation conference recommendation: At the conclusion of the conciliation conference, the conciliation moderator may issue a recommendation memorializing the results of the conference and scheduling future deadlines where appropriate. The Court may enter an order based on the recommendation, as appropriate.

6. This Administrative Order shall take effect thirty days from the date of publication in the *Pennsylvania Bulletin* and remain in effect until December 31, 2010, unless extended by the Court.



Meeting and Public Hearing

The Delaware River Basin Commission (Commission) will hold a meeting and public hearing on Wednesday, July 15, 2009. The hearing will be part of the Commission's regular business meeting, which is open to the public. The meeting will be held at the Northampton Community College's Fowler Family Southside Center, 511 East 3rd Street, 6th Floor, Room 605, Bethlehem, PA.

No morning conference session is planned in connection with this meeting. The subjects of the public hearing to be held during the 1 p.m. business meeting include the dockets listed as follows:

1. Borough of Ambler D-75-16 CP-3. An application for the renewal of the Ambler Borough Wastewater Treatment Plant (WWTP). The existing WWTP will continue to discharge treated effluent at an annual average flow of 6.5 million gallons per day (mgd) and a maximum monthly flow of 8.0 mgd. The WWTP discharges to the Wissahickon Creek, a tributary to the Schuylkill River. The facility is located in Upper Dublin Township, Montgomery County, PA in the Southeastern Pennsylvania Ground Water Protected Area.

2. *Moon Nurseries D-88-28-3*. An application for the renewal of a groundwater withdrawal project to continue the withdrawal of 8 million gallons per thirty days (mg/30 days) to supply the applicant's irrigation supply from existing Well No. 1 in the Stockton Formation. The project is located in the Core Creek Watershed in Lower Makefield Township, Bucks County, PA within the South-eastern Pennsylvania Ground Water Protected Area.

3. Solvay Solexis D-69-84-3. An application to renew the withdrawal of water from two existing groundwater wells (Wells Nos. 417 and 418) and four existing groundwater remediation wells (Wells Nos. RW-1, RW-2, RW-3 and RW-4). In addition, pump capacity for remediation Wells Nos. RW-1, RW-2, RW-3 and RW-4 will increase from 48 gallons per minute (gpm), 48 gpm, 141 gpm, and 98 gpm to 60 gpm, 60 gpm, 250 gpm and 250 gpm, respectively. The increased pump capacities for the remediation wells accompany an increase in the 30 day average withdrawal from 14.91 million (mg) to 18.84 mg for the four remediation wells. However, the overall 30 day average and yearly withdrawals will decrease from 74.91 mg and 476.68 mg to 60 mg and 301.13 mg, respectively. The project wells are located in the Upper and Lower Potomac-Raritan-Magothy (PRM) Formation, in the Delaware River Watershed, in West Deptford Township, Gloucester County, NJ.

4. Waste Management Disposal Services of Pennsylvania, Inc. D-88-54-5. An application to replace a 0.1 mgd landfill leachate treatment plant (LTP) with a 0.3 mgd treatment facility, which will discharge to the tidal Delaware River by means of a new outfall in Water Quality Zone 2 at River Mile 125.64. The LTP serves the GROWS and Tullytown Sanitary Landfills and is located off Bordentown Road in Falls Township, Bucks County, PA.

5. BP Oil Company D-91-32-5. An application for renewal of a groundwater withdrawal project that will decrease the total monthly average and yearly withdrawals of 30 mg/30 days and 365 million gallons per year (mpy), respectively, to 21.6 mg/30 days and 207 mgy, respectively. Withdrawals will occur from existing Wells Nos. R-3, MW-R5, R-4A, R-5A, R-6A, R-8, R-9, R-10, R-11 and R-12. Additionally, this docket will approve the renewal of a discharge of treated remediation water from the docket holder's 1.0 mgd groundwater treatment plant (GWTP). The project wells are located in the Mantua Creek and the Delaware River Watersheds within the PRMFormation, in Paulsboro Borough, Gloucester County, NJ. The contaminated groundwater is treated and discharged to the Delaware River, approximately 2,000 feet downstream of the Mantua Creek confluence, by means of Outfall No. 003A located at River Mile 89.3 in Commission Basin Water Quality Zone 4.

6. Shoemakersville D-93-74 CP-2. The purpose of this project is to recognize the increase in capacity of the Shoemakersville WWTP's hydraulic load from 0.60 mgd to 0.75 mgd. Additionally, a TDS determination was submitted, requesting approval of monthly average and instantaneous maximum concentration values of 3,300 mg/l and 4,000 mg/l, respectively. The project is located on the Schuylkill River at River Mile 92.47-92.3, in the Borough of Shoemakersville, Berks County, PA.

7. Bucks County Water and Sewer Authority D-93-76 CP-2. An application for approval of a modification to the Bucks County Water and Sewer Authority (BCWSA) Upper Dublin WWTP. The application is for the addition of a ferric chloride chemical feed system. The project also includes the transfer of ownership from Upper Dublin Township to the BCWSA and the rerate of the average annual daily flow rate of the existing WWTP from 0.85 mgd to 1.10 mgd. The WWTP will continue to discharge to Pine Run, a tributary to the Wissahickon Creek, which is a tributary to the Schuylkill River. The facility is located in Upper Dublin Township, Montgomery County, PA.

8. Richland Township Water Authority D-96-44 CP-3. An application for approval of a ground water withdrawal project to supply up to 15 mg/30 days of water to the applicant's public water supply from new Well No. QCS-1 and to increase the maximum combined withdrawal from all wells from 31.55 mg/30 days to 46.55 mg/30 days. The project is located in the Brunswick Formation in the Morgan Creek Watershed in Richland Township, Bucks County, PA, in the Southeastern Pennsylvania Ground Water Protected Area. This withdrawal project is located within the drainage area to the section of the nontidal Delaware River known as the Lower Delaware, which is designated as Special Protection Waters.

9. Borough of Portland D-2003-9 CP-3. An application to modify the service area of the existing 0.105 mgd Portland WWTP. The project proposes to add the 12.4acre "Gary Gray parcel" to the Portland Industrial Park. The Gary Gray parcel, located in Upper Mount Bethel Township, will be developed with the Voltaix Land Development project. This project does not propose an increase in allocation of flow due to the development, and all wastewater generated by the development discharged to the WWTP for treatment will be sanitary waste. The facility will discharge directly to the section of the nontidal Delaware River known as the Lower Delaware, which is designated as Special Protection Waters. The project is located in the Borough of Portland, Northampton County, PA.

10. Penn Estate Utilities, Inc. D-2003-36 CP-2. An application for approval of a groundwater withdrawal project to supply up to 1.642 mg/30 days of water to the applicant's public water supply system from new Well No. 8 and to increase the existing withdrawal from all wells from 10.80 mg/30 days to 12.025 mg/30 days. The increased allocation is requested to meet current needs in service area demand. The project is located in the Trimmers Rock Formation in the Brodhead Creek Watershed in Stroud Township, Monroe County, PA. The site is located within the drainage area to the section of the nontidal Delaware River known as the Middle Delaware, which is designated as Special Protection Waters.

The site is located within the drainage area to the section of the nontidal Delaware River known as the Middle Delaware, which is designated as Special Protection Waters.

13. Sunny Side Farms, Inc. D-2008-31-1. A groundwater withdrawal project to supply a maximum of 61.7 mg/30 days of water for the irrigation of approximately 275 acres of vegetable crops from three wells—Pizzo Farm Well, Pipitone Toni Well and Tedesco Well. The wells are located in the Cohansey Formation in the Maurice River Watershed in Deerfield Township, Cumberland County, NJ.

14. Exelon Generation Company, LLC D-2008-38-1. An application for approval of an existing surface water withdrawal project to continue to supply up to 44,064 mg/30 days of water to the applicant's Eddystone Power Generating Station from existing Intakes Nos. 1—4. An application for renewed approval to discharge 0.20 mgd of treated effluent from the existing Buck Hill Falls WWTP, located at River Mile 213.00—21.11—0.50 (Delaware River— Brodhead Creek—Buck Hill Creek). The project is located within the drainage area to the section of the nontidal Delaware River known as the Middle Delaware, which is designated Special Protection Waters with the classification Outstanding Basin Waters. The project is located in Barrett Township, Monroe County, PA.

18. Parkland School District D-2009-7 CP-1. An application for approval of the existing 33,600 gpd WWTP serving the Orefield Middle School in South Whitehall Township, Lehigh County, PA. 19. Lower Milford Township D-2009-10 CP-1. An application for approval to construct and operate a new 0.035 mgd WWTP. The WWTP is located in Lower Milford Township, Lehigh County, PA within the drainage area of the section of the nontidal Delaware River known as the Lower Delaware, which is designated as Special Protection Waters. The facility will discharge to Saucon Creek, a High Quality-Cold Water Fishery that flows to the Lehigh River at River Mile 183.66—9.43—14.64 (Delaware River—Lehigh River—Saucon Creek).

20. Chesapeake Appalachia, LLC D-2009-20-1. A surface water withdrawal project to supply a maximum of 29.99 mg/30 days of water for the applicant's exploration and development of natural gas wells in the State of New York and PA. Surface water will be withdrawn from the

West Branch of the Delaware River at a location known as the Curtone site in Buckingham Township, Wayne County, PA. This withdrawal project is located in the Delaware River Watershed within the drainage area of the section of the nontidal Delaware River known as the Upper Delaware, which is designated as Special Protection Waters.

LAND RECYCLING AND ENVIRONMENTAL REMEDIATION

UNDER ACT 2, 1995

PREAMBLE 1

Acknowledgment of Notices of Intent to Remediate Submitted under the Land Recycling and Environmental Remediation Standards Act (35 P.S. §§ 6026.101-6026.908).

Sections 302-305 of the Land Recycling and Environmental Remediation Standards Act (act) require the Department of Environmental Protection (Department) to publish in the Pennsylvania Bulletin an acknowledgment noting receipt of Notices of Intent to Remediate. An acknowledgment of the receipt of a Notice of Intent to Remediate is used to identify a site where a person proposes to, or has been required to, respond to a release of a regulated substance at a site. Persons intending to use the Background Standard, Statewide Health Standard, the Site-Specific Standard or who intend to remediate a site as a special industrial area must file a Notice of Intent to Remediate with the Department. A Notice of Intent to Remediate filed with the Department provides a brief description of the location of the site, a list of known or suspected contaminants at the site, the proposed remediation measures for the site and a description of the intended future use of the site. A person who demonstrates attainment of one, a combination of the cleanup standards or who receives approval of a special industrial area remediation identified under the act will be relieved of further liability for the remediation of the site for any contamination identified in reports submitted to and approved by the Department. Furthermore, the person shall not be subject to citizen suits or other contribution actions brought by responsible persons not participating in the remediation.

Under sections 304(n)(1)(ii) and 305(c)(2) of the act, there is a 30-day public and municipal comment period for sites proposed for remediation using a Site-Specific Standard, in whole or in part, and for sites remediated as a special industrial area. This period begins when a summary of the Notice of Intent to Remediate is published in a newspaper of general circulation in the area of the site. For the sites identified, proposed for remediation to a Site-Specific Standard or as a special industrial area, the municipality within which the site is located may request to be involved in the development of the remediation and reuse plans for the site if the request is made within 30 days of the date specified. During this comment period, the municipality may request that the person identified as the remediator of the site develop and implement a public involvement plan. Requests to be involved and comments should be directed to the remediator of the site.

For further information concerning the content of a Notice of Intent to Remediate, contact the environmental cleanup program manager in the Department regional office before which the notice appears. If information concerning this acknowledgment is required in an alternative form, contact the community relations coordinator at the appropriate regional office. When a National Pollutant Discharge Elimination System (NPDES) number is listed, the mining activity permit application was accompanied by an application for an individual NPDES permit. The Department has made a tentative determination to issue the NPDES permit in conjunction with the mining activity permit, but the issuance of the NPDES permit is contingent upon the approval of the associated mining activity permit.

For coal mining activities, NPDES permits, when issued, will contain effluent limits that do not exceed the technology-based effluent limitations. The proposed limits are listed in Table 1.

Other specific factors to be considered include public comments and Total Maximum Daily Loads (TMDLs).

Comments received within the comment period will be considered in the final determinations regarding the NPDES permit applications. If required, a risk assessment report describes potential adverse effects caused by the presence of regulated substances. If required, a cleanup plan evaluates the abilities of potential remedies to achieve remedy requirements.

remedies to achieve remedy requirements. A work plan for conducting a baseline remedial investigation is required by provisions of the act for compliance with selection of a special industrial area remediation. The baseline remedial investigation, based on the work plan, is compiled into the baseline environmental report to establish a reference point to show existing contamination, describe proposed remediation to be done and include a description of existing or potential public benefits of the use or reuse of the property. The Department may approve or disapprove plans and reports submitted. This notice provides the Department's decision and, if relevant, the basis for disapproval.

Measures Under Consideration by the Ozone Transport Commission; Public Meetings and Comment Period

The Department of Environmental Protection (Department) is seeking comments on potential control measures under consideration by the Ozone Transport Commission (OTC). The Department has scheduled three public meetings to present an overview of the Federal Clean Air Act (CAA) requirements, the need for Pennsylvania to adopt additional measures for the achievement and maintenance of the ozone and fine particulate standards, and the potential control measures under consideration by the OTC. The Department will also be accepting public comments for 30 days, consistent with the requirements of section 7.4 of the Pennsylvania Air Pollution Control Act (35 P. S. § 4007.4).

The OTC is a multi-state organization created under the CAA that is responsible for advising the United States Environmental Protection Agency (EPA) on pollution transport issues and for developing and implementing regional solutions to the ground-level ozone problem in the Northeast and Mid-Atlantic regions. The Commonwealth is a member of the OTC. The OTC intends to take action on the adoption of a model rule for control of emissions from automobile repair and refinishing; therefore, the Department is asking for comment on this model rule. The OTC may also take action at its November 2009 meeting to approve a list of stationary and area control measures for evaluation by the organization and eventual consideration for adoption by its member states.

The EPA has the responsibility to establish National Ambient Air Quality Standards (NAAQS) to protect human health and the environment. When the EPA establishes a NAAQS, States must submit State Implementation Plans (SIPs) to demonstrate attainment of the NAAQS in a timely fashion. In October 2006, the EPA promulgated a revised fine particulate standard and, in March 2008, a revised ozone standard. This Commonwealth is likely to have a number of areas that do not meet these revised standards, so the Department will likely have to submit SIPs to EPA to meet the Commonwealth's CAA obligations. Pennsylvania will work cooperatively with OTC and other regional organizations to develop cost-effective strategies for attaining the NAAQS and to develop the necessary air quality attainment demonstrations.

OTC has adopted resolutions setting forth the process and schedules for developing these strategies and attainment demonstrations, including work by modeling, stationary and area source, and modeling committees. The OTC held a public meeting for stakeholders on February 4, 2009, on potential control measures and intends to continue consultation with stakeholders as it develops its inventory, modeling and potential control measures. The resolutions, materials describing the potential control measures, and the text of the model motor vehicle and mobile equipment refinishing and recoating rule can be found on the Department's web site at www.depweb. state.pa.us, choose Air Quality. Additional materials can be found at the OTC web site, www.otcair.org, choose "Meetings."

Potential Federal and State control measures are being discussed from stationary and area sources to help achieve and maintain the ozone and fine particulate NAAQS, including the following:

• Additional reductions of volatile organic compound (VOC) emissions from motor vehicle and mobile equipment refinishing and recoating (model rule available)

• Additional controls on boilers serving electric generating units

• Controls based on ultra-low nitrogen oxides burners for natural gas boilers

- Additional controls on municipal waste incinerators
- Stationary distributed generator regulation
- Additional reductions of VOC emissions from:
 - architectural and industrial maintenance coatings
 - solvents and degreasers
 - gasoline refueling stations
 - large gasoline storage tanks

The OTC is also evaluating and quantifying the emission effects of a number of Federal, regional and state mobile source sector measures. For information on these measures, see the papers posted for the OTC February 4, 2009, stakeholders meeting.

Adoption by the OTC of any of these measures as a model rule, or agreement by any state to consider promulgation of any of these measures as a state regulation, is not a Pennsylvania rulemaking. Any control measure considered by Pennsylvania for promulgation as a state regulation would be subject to the Commonwealth's notice and comment rulemaking process under sections 201 and 202 of the act of July 31, 1968 (45 P. S. §§ 1201 and 1202) known as the Commonwealth Documents Law, the Regulatory Review Act (71 P. S. §§ 745.1—745.12) and Commonwealth Attorneys Act (71 P. S. §§ 732-101—732-506).

Payment for Nursing Facility Services Provided by County Nursing Facilities; Medicaid Day One Incentive Payments to County Nursing Facilities for Fiscal Years 2009-2010 and 2010-2011

Purpose

This announcement is to provide advance notice that the Department of Public Welfare (Department) intends to make changes in its methods and standards for payment of Medical Assistance (MA) nursing facility services for qualified county nursing facilities for Fiscal Years (FY) 2009-2010 and 2010-2011.

Background

On October 22, 2008, the Department entered into an agreement with the County Commissioners Association of Pennsylvania that authorizes the transfer of funds to the Commonwealth from several counties as authorized under 42 U.S.C.A. § 1396b(w)(6)(A) (relating to payment to States) and 42 CFR 433.51(b) (relating to funds from units of government as the State share of financial participation). Funds from the intergovernmental transfer (IGT) will be used as the State share for a portion of the Medicaid Day One Incentive Payments (MDOI) to qualified county nursing facilities during FYs 2009-2010 and 2010-2011.

For FYs 2006-2007 through 2008-2009 the Department provided MDOI payments to qualified county nursing facilities. The qualifying criteria and formula used to determine these payments, as set forth in the Commonwealth's approved State Plan, are:

To qualify for MDOI payments the nursing facility must be a county nursing facility both during the entire quarter for which the MDOI installment payment is being made and at the time the MDOI installment payment is made.

The Department will calculate each qualified county nursing facility's MDOI quarterly installment payment based on the following formula:

(i) The total funds allocated for the MDOI payments for the rate year will be divided by the total MA days for all county nursing facilities to determine the MDOI per diem for the rate year. The total MA days used for each county nursing facility will be the MA days identified on the most recent PROMISe data file used to determine the facility's eligibility for disproportionate share incentive payments.

(ii) The MDOI per diem for the rate year will be multiplied by each qualified county nursing facility's paid MA days identified on the most recent PROMISe data file used to determine eligibility for disproportionate share incentive payments, to determine its annual MDOI amount.

(iii) Each qualified county nursing facility's annual MDOI amount will be divided by four to determine the facility's MDOI quarterly installment payments for the rate year.

The MDOI installment payments for each quarter of the rate year will be paid in the first month of the following quarter.

In accordance with the IGT agreement of October 22, 2008, the MDOI payments for FYs 2009-2010 and 2010-2011 will continue to be made based on the formula in the Commonwealth's currently approved State Plan. In addition, for FY 2009-2010, the Department will use a portion of the revenues generated from the FY 2009-2010 Nursing Facility Assessment Program (The Act of June 30, 2007, P. L. 49 No. 16 (Act 16)) to increase the funding level for the county nursing facility MDOI.

To authorize the continuance of the MDOI payments for FYs 2009-2010 and 2010-2011, and the increase in the funding level for the MDOI payments for FY 2009-2010, the Department will submit a State Plan Amendment (SPA) to the Federal Centers for Medicare and Medicaid Services (CMS).

If CMS approves the SPA the Department will have the authority to continue to make MDOI payments to county nursing facilities for FYs 2009-2010 and 2010-2011, and increase the funding level for the MDOI for FY 2009-2010.

The MDOI payments to county nursing facilities will provide incentives to county nursing facilities to admit individuals who are MA eligible on the day of admission. Nursing facilities are often reluctant to admit residents whose only source of coverage for nursing facility services is MA. County nursing facilities have traditionally acted as the safety net for those residents who have been denied admission to other nursing facilities. The MDOI payments are intended to assure that county nursing facilities continue to provide access to care for these individuals. These payments provide an incentive to county nursing facilities to continue to operate as safety net providers for the poor and indigent citizens of Pennsylvania.

Fiscal Impact

The estimated increase in annual aggregate expenditures during FY 2009-2010 is \$13.916 million in State funds and during FY 2010-2011 is \$14.701 million in State funds.

Autism Review Process; Insurance Department Notice 2009-06

This notice is issued to all persons and entities impacted by section 635.2 of the act of Insurance Company Law of 1921 (P. L. 682, No. 284), added by section 2 of Act 62 of 2008 (40 P. S. § 764h) concerning the review process for any "denial or partial denial by an insurer of a claim for diagnostic assessment of autism spectrum disorders or a claim for treatment of autism spectrum disorders" ("autism related issues"). As specified in Act 62, "a covered individual or an authorized representative [a "challenger"] shall be entitled to an expedited internal review process pursuant to the procedures set forth in Article XXI, followed by an expedited independent external review process established and administered by the Insurance Department."

Unless Act 62 regulations are promulgated, the Insurance Department intends to utilize procedures for internal review and independent external review parallel to those set forth in Article XXI (specified in 40 P.S. § 991.2101 and 28 Pa. Code Ch. 9, Subch. I (relating to complaints and grievances). However, therewill be two

exceptions with respect to requests for an expedited independent external review. First, there will be no provision for direct access by a plan to a Certified Utilization Review Entity (CRE) on weekends and State holidays. Second, the Insurance Department will assign a CRE within 2 business days of receiving the request for an expedited review.

Further, the Insurance Department interprets Act 62 to entitle the challenger to an expedited review process for autism related issues, but not to preclude the challenger from a nonexpedited review process. A nonexpedited review process will be used if the challenger does not meet the expedited time frames or if the challenger opts for a nonexpedited review. For purposes of autism related issues, the Insurance Department will oversee both nonexpedited and expedited reviews.

Extension of the Fuel Cost Recovery Surcharge; R-2009-2108518; S.P. 28209

Order

By the Commission:

The Pennsylvania Public Utility Commission (Commission) by its Fuel Cost Recovery Surcharge Order at Special Permission Number 28209, ratified June 1, 2006, authorized call or demand, paratransit, and airport transfer carriers under the jurisdiction of this Commission to adjust rates and fares to offset significant increases in the cost of fuel. The fuel surcharge became effective on July 1, 2006, and was extended on June 24, 2008. It is currently scheduled to terminate on June 30, 2009.

In a letter dated May 14, 2009, the Pennsylvania Taxicab and Paratransit Association (PTPA), on behalf of its members, has requested that this Commission extend the fuel cost recovery surcharge for a period of 1 year. PTPA cites the ongoing instability of retail gasoline prices as the reason for this request.

Initially, all call or demand, paratransit and airport transfer carriers were authorized to collect the surcharge found on the Fuel Surcharge page of the Commission's web site. The average price of fuel was posted on the third Friday of each month, with the effective date of the surcharge being the first day of the subsequent month. The Commission determined the average cost of unleaded regular gasoline based upon gasoline prices in the index of the Energy Information Administration of the United States Department of Energy (Department). The amount of the fuel surcharge was determined by locating the average price of gasoline on a chart, also displayed on that page, and selecting the corresponding fuel surcharge in the column for the respective type of transportation.

Determination of the amounts to be charged was based on the cost of gasoline per trip. The constants used for calculations were those based upon statistics from the Taxicab, Limousine and Paratransit Association: The average trip length of 6.8 miles for call or demand carriers and 13.61 miles for paratransit and airport transfer carriers; the average miles per gallon per vehicle of 15.04 for call or demand carriers and 13.01 for paratransit and airport transfer carriers; and \$1.35 per gallon of unleaded regular gasoline (the average cost in 2002 according to Energy Information Administration of the Department. The cost per trip was calculated by multiplying the price of gasoline by the ratio of miles per trip to miles per gallon. The cost per trip at \$1.35 per gallon would serve as the base line. The results are tabulated in the chart to follow.

The Commission's intention was to create flexibility for both the carriers and the Commission. By establishing gasoline prices which would "trigger" a change in the surcharge, it would no longer be necessary to monitor the surcharge at different intervals. This flexibility would also aid in eliminating the need for emergency petitions, as was the case following Hurricane Katrina in 2005.

In the process of considering this request, the Commission has analyzed current information available from the Energy Information Administration of the Department, the American Automobile Association and OPIS Energy Group. Data from these groups indicate that the retail price of gasoline will continue to increase throughout the summer months and even beyond, due to increased demand and the uncertainty of supply.

Many refineries have failed to return from unplanned outages and maintenance. Should more unplanned outages occur, there will be a significant impact on the future path of prices. Several analysts expect to see refinery maintenance remain relatively high even into June. High import volumes also play a part in keeping supplies adequate. Additionally, there remain many trouble spots across the globe that could affect the crude oil supply, prices and gasoline prices (such as, Venezuela, Nigeria, Iran, and the like). Projections such as this indicate that the cost of gasoline will remain a problem for the transportation industry.

Based on our review, it appears that an extension of the Fuel Cost Recovery is an appropriate way to address the high costs and instability of gasoline prices at the present time. However, the industry should not continue to rely on this measure as a means of relief. Members of the industry will have the responsibility of taking appropriate measures.

After due consideration, we have determined that fuel costs are not likely to decrease. Based upon the evidence available, we are of the opinion that the passenger motor carrier industry continues to have a need for the Fuel Cost Recovery Surcharge to permit the recovery of fuel expenditures; *Therefore*,

It Is Ordered that:

1. The Fuel Cost Recovery Surcharge established at Special Permission No. 28209 be and is hereby extended until June 30, 2010, unless changed, cancelled or extended by the Commission.

2. On the third Friday of every month, the Commission shall post on its web site at www.puc.state.pa.us/trans port/motor/fuel_surcharge.aspx the average cost of unleaded regular gasoline upon which the surcharge will be determined.

3. Call or demand, paratransit, and airport transfer carriers rendering transportation service under the jurisdiction of the Pennsylvania Public Utility Commission shall notify the public by placing a notice in all vehicles, which shall read: "The PA Public Utility Commission has authorized a fuel surcharge under Special Permission No. 28209. The surcharge has been extended and shall terminate on June 30, 2010. The current surcharge is (**insert current charge here**) per trip for each paying passenger."

4. The Fuel Cost Recovery Surcharge established at Special Permission No. 28209 be continued until midnight, June 30, 2010, at which time it will expire.

5. The Secretary of this Commission shall duly certify this order and deposit same with the Legislative Reference Bureau for publication in the *Pennsylvania Bulletin*.
