# READER'S GUIDE TO THE PENNSYLVANIA BULLETIN AND PENNSYLVANIA CODE

## *Pennsylvania Bulletin*

The *Pennsylvania Bulletin* is the official gazette of the Commonwealth of Pennsylvania. It is published every week and includes a table of contents. A cumulative subject matter index is published quarterly.

The *Pennsylvania Bulletin* serves several purposes. First, it is the temporary supplement to the *Pennsylvania Code*, which is the official codification of agency rules and regulations and other statutorily authorized documents. Changes in the codified text, whether by adoption, amendment, repeal or emergency action must be published in the *Pennsylvania Bulletin*. Further, agencies proposing changes to the codified text do so in the *Pennsylvania Bulletin*.

Second, the *Pennsylvania Bulletin* also publishes: Governor's Executive Orders; State Contract Notices; Summaries of Enacted Statutes; Statewide and Local Court Rules; Attorney General Opinions; Motor Carrier Applications before the Pennsylvania Public Utility Commission; Applications and Actions before the Department of Environmental Protection; Orders of the Independent Regulatory Review Commission; and other documents authorized by law.

The text of certain documents published in the *Pennsylvania Bulletin* is the only valid and enforceable text. Courts are required to take judicial notice of the *Pennsylvania Bulletin*.

### **Adoption, Amendment or Repeal of Regulations**

Generally an agency wishing to adopt, amend or repeal regulations must first publish in the *Pennsylvania Bulletin* a Notice of Proposed Rulemaking. There are limited instances when the agency may omit the proposal step; it still must publish the adopted version.

The Notice of Proposed Rulemaking contains the full text of the change, the agency contact person, a fiscal note required by law and background for the action.

The agency then allows sufficient time for public comment before taking final action. An adopted proposal must be published in the *Pennsylvania Bulletin* before it can take effect. If the agency

wishes to adopt changes to the Notice of Proposed Rulemaking to enlarge the scope, it must repropose.

### **Citation to the *Pennsylvania Bulletin***

Cite material in the *Pennsylvania Bulletin* by volume number, a page number and date. Example: Volume 1, *Pennsylvania Bulletin*, page 801, January 9, 1971 (short form: 1 Pa.B. 801 (January 9, 1971)).

### ***Pennsylvania Code***

The *Pennsylvania Code* is the official codification of rules and regulations issued by Commonwealth agencies and other statutorily authorized documents. The *Pennsylvania Bulletin* is the temporary supplement to the *Pennsylvania Code*, printing changes as soon as they occur. These changes are then permanently codified by the *Pennsylvania Code Reporter*, a monthly, loose-leaf supplement.

The *Pennsylvania Code* is cited by title number and section number. Example: Title 10 *Pennsylvania Code*, § 1.1 (short form: 10 Pa. Code § 1.1).

Under the *Pennsylvania Code* codification system, each regulation is assigned a unique number by title and section. Titles roughly parallel the organization of Commonwealth government. Title 1 *Pennsylvania Code* lists every agency and its corresponding *Code* title location.

### **How to Find Documents**

Search for your area of interest in the *Pennsylvania Code*. The *Pennsylvania Code* is available at [www.pacode.com](http://www.pacode.com).

Source Notes give you the history of the documents. To see if there have been recent changes, not yet codified, check the List of *Pennsylvania Code* Chapters Affected in the most recent issue of the *Pennsylvania Bulletin*.

The *Pennsylvania Bulletin* also publishes a quarterly List of Pennsylvania Code Sections Affected which lists the regulations in numerical order, followed by the citation to the *Pennsylvania Bulletin* in which the change occurred. ### Printing Format

Material proposed to be added to an existing rule or regulation is printed in **bold face** and material proposed to be deleted from such a rule or regulation is enclosed in brackets [ ] and printed in **bold face**. Asterisks indicate ellipsis of *Pennsylvania Code* text retained without change. Proposed new or additional regulations are printed in ordinary style face.

### Fiscal Notes

Section 612 of The Administrative Code of 1929 (71 P. S. § 232) requires that the Office of Budget prepare a fiscal note for regulatory actions and administrative procedures of the administrative departments, boards, commissions or authorities receiving money from the State Treasury stating whether the proposed action or procedure causes a loss of revenue or an increase in the cost of programs for the Commonwealth or its political subdivisions; that the fiscal note be published in the *Pennsylvania Bulletin* at the same time as the proposed change is advertised; and that the fiscal note shall provide the following information: (1) the designation of the fund out of which the appropriation providing for expenditures under the action or procedure shall be made; (2) the probable cost for the fiscal year the program is implemented; (3) projected cost estimate of the program for each of the five succeeding fiscal years; (4) fiscal history of the program for which expenditures are to be made; (5) probable loss of revenue for the fiscal year of its implementation; (6) projected loss of revenue from the program for each of the five succeeding fiscal years; (7) line item, if any, of the General Appropriation Act or other appropriation act out of which expenditures or losses of Commonwealth funds shall occur as a result of the action or procedures; (8) recommendation, if any, of the Secretary of the Budget and the reasons therefor.

The required information is published in the foregoing order immediately following the proposed change to which it relates; the omission of an item indicates that the agency text of the fiscal note states that there is no information available with respect thereto. In items (3) and (6) information is set forth for the first through fifth fiscal years; in that order, following the year the program is implemented, which is stated. In item (4) information is set forth for the current and two immediately preceding years, in that order. In item (8) the recommendation, if any, made by the Secretary of Budget is published with the fiscal note. See 4 Pa. Code § 7.231 *et seq.* Where “no fiscal impact” is published, the statement means no additional cost or revenue loss to the Commonwealth or its local political subdivision is intended.

### Reproduction, Dissemination or Publication of Information

Third parties may not take information from the *Pennsylvania Code* and *Pennsylvania Bulletin* and reproduce, disseminate or publish such information except as provided by 1 Pa. Code § 3.44. 1 Pa. Code § 3.44 reads as follows:

#### § 3.44. General permission to reproduce content of Code and Bulletin.

Information published under this part, which information includes, but is not limited to, cross references, tables of cases, notes of decisions, tables of contents, indexes, source notes, authority notes, numerical lists and codification guides, other than the actual text of rules or regulations may be reproduced only with the written consent of the Bureau. The information which appears on the same leaf with the text of a rule or regulation, however, may be incidentally reproduced in connection with the reproduction of the rule or regulation, if the reproduction is for the private use of a subscriber and not for resale. There are no other restrictions on the reproduction of information published under this part, and the Commonwealth hereby consents to a reproduction.

## Title 210—APPELLATE PROCEDURE

### PART I. RULES OF APPELLATE PROCEDURE

[ 210 PA. CODE CHS. 19 AND 25 ]

#### Proposed Amendments to Pa.R.A.P. 1972 and 2542

#### DISPOSITION WITHOUT REACHING THE MERITS

#### Rule 1972. Dispositions on Motion.

**Official Note:** [ Based on former Supreme Court Rule 33 and former Superior Court Rule 25.

As to Paragraph (6), see, e.g. *Commonwealth v. Galloway*, 460 Pa. 309, 333 A.2d 741 (1975) (continuing generally), *Commonwealth v. Barron*, 237 Pa. Super. 369, 352 A.2d 84 (1975) (quashing). ]

If an appellate court dismisses a criminal appeal under Pa.R.A.P. 1972(a)(6), the fugitive forfeits rather than simply waives the right to assert errors the fugitive might otherwise have raised on direct appeal, and the fugitive may not raise those errors on collateral review. *Commonwealth v. Judge*, 797

A.2d 250, 255, 258-60 (Pa. 2002); *Commonwealth v. Doty*, 48 A.3d 451 (Pa. Super. 2012) (on PCRA); 997 A.2d 1184 (Pa. Super. 2010) (on direct appeal). Forfeiture under this Rule does not limit any review under 42 Pa.C.S. § 9711(h) or Pa.R.A.P. 1941 (Review of Death Sentences).

[ Rule 1933 (record for preliminary hearing in appellate court) ] Pa.R.A.P. 1933 makes clear the right of a moving party to obtain immediate transmission of as much of the record as may be necessary for the purposes of a motion under this rule. See [ Rule 123(c) (speaking applications) ] Pa.R.A.P. 123(c).

#### CHAPTER 25. POST-SUBMISSION PROCEEDINGS

#### APPLICATION FOR REARGUMENT

Rule 2542. Time for Application for Reargument[. ],  
**Reconsideration or Rehearing;** Manner of Filing.

(a) *Time.*

(1) *General rule.*—Except as otherwise prescribed by this rule **or by Pa.R.A.P. 1123(b) or Pa.R.A.P. 3814**, an application for reargument **or for reconsideration of a dispositive order** shall be filed with the prothonotary within [ 14 ] 30 days after entry of the judgment or other order involved.

(2) *Children's fast track appeals.*—In a children's fast track appeal, an application for reargument **or for reconsideration of a dispositive order** shall be filed with the prothonotary within 7 days after entry of the judgment or other order involved.

\* \* \* \* \*

**Official Note:** [ Former Supreme Court Rule 64, former Superior Court Rules 55 and 58 and former Commonwealth Court Rule 113A required the application for reargument to be filed within ten days of the entry of the order. Under Rule 105(b) (enlargement of time) the time for seeking reargument may be enlarged by order, but no order of the Superior Court or of the Commonwealth Court, other than an actual grant of reargument meeting the requirements of Rule 1701(b)(3) (authority of lower court or agency after appeal), will have the effect of postponing the finality of the order involved under Rule 1113 (time for petitioning for allowance of appeal).

The 1986 amendment provided that an application shall be deemed received on the date deposited in the United States mail as shown on a United States Postal Service Form 3817 Certificate of Mailing.

The 2008 amendment provides that an application shall be deemed received on the date deposited in the United States mail as shown on a United States Postal Service Form 3817 Certificate of Mailing or other similar United States Postal Service form from which the date of deposit can be verified. ]

This does not affect the 14-day requirement for reconsideration of a petition for allowance of appeal under Pa.R.A.P. 1123(b) or under the Abortion Control Act.

**Explanatory Comment***Proposed Amendment to Note to Pa.R.A.P. 1972*

Pa.R.A.P. 1972 addresses appeals that may be dismissed on motion. Paragraph (a)(6) of the rule allows a motion to continue or dismiss because the appellant is a fugitive.

The purpose of the proposed amendment to the note to this rule pertains to paragraph (a)(6) and is to conform the note to reflect more recent case law holding that, although dismissal pursuant to a motion under paragraph (a)(6) or *sua sponte* is not a *per se* rule, a returning fugitive returns to the case in the posture in which it stands at the time of the fugitive's return and with the consequences attendant to that return.

The proposed amendment to the note also explains that, if an appeal is dismissed, appellate rights—except for those guaranteed by 42 Pa.C.S. § 9711(h)—are forfeited, not simply waived, and errors that would have been raised on direct appeal cannot be reviewed collaterally.

*Proposed Amendment to Pa.R.A.P. 2542 and Note*

Pa.R.A.P. 2542 addresses the time for reargument, reconsideration or rehearing and makes it consistent with the 30-day statutory time for reconsideration under 42 Pa.C.S. § 5505, except in limited circumstances, such as children's fast track (must be filed within seven days); or under Pa.R.A.P. 1123 or 3814.

The proposed amendment to the note to Pa.R.A.P. 2542 explains that, the amendment to the rule extending the time limit generally does not affect the 14-day requirement for reconsideration of a petition for allowance of appeal under Pa.R.A.P. 1123(b) or under the Abortion Control Act.

The remaining proposed amendments to the note to Pa.R.A.P. 2542 eliminate unnecessary language and are ministerial in nature.

GENERALLY****ATTORNEYS AND COUNSELORS**Rule 3121. Practice of Law by Staff; **Qualifications.**

**A.** Neither the prothonotary, deputy prothonotary, chief clerk, nor any person employed in the Office of the Prothonotary, nor any [ **law clerk, administrative assistant, or secretary** ] **personal staff** employed by an appellate court or by any judge thereof, shall practice [ **in the court** ] **before any court or tribunal of this Commonwealth.** Nor shall any such person otherwise practice law [ **without prior approval of the judge on whose staff such person is employed or of the president judge if such person is not so employed** ]. **Such a person may act *pro se*, and may perform routine legal work incident to the management of the personal affairs of the person or a member of the person's family, as long as the work is performed without compensation and does not involve the entry of an appearance on behalf of the family member in a court or other tribunal. Such limited practice is also subject to the disclosure of employment within the Unified Judicial System to the parties and the court in which the employee represents himself or herself.**

**This rule does not apply to *pro bono* activities, provided that they are performed without compensation; do not involve the entry of an appearance before any court or tribunal; do not involve a matter of public controversy, an issue likely to come before the person's court, or litigation against federal, state or local government; and are undertaken after written approval of the Justice or Judge for whom the person is employed and the Chief Justice, or the President Judge of the Superior Court or Commonwealth Court, depending on which court employs the person.**

**B. Staff attorneys must either be members of the Bar of Pennsylvania, or must have received without exception an earned Bachelor of Laws or Juris Doctor degree from a law school that was an accredited law school at the time the staff attorney matriculated or graduated.**

**Official Note:** Based on former Supreme Court Rule 6, former Superior Court Rule 4 and former Commonwealth Court Rule 60[ , and makes no change in substance except to require approval by the appointing authority of the continuance of an outside law practice ]. See 42 Pa.C.S. § 102 (defining "personal staff").**

#### Rule L1907. Constables; Policies, Procedures and Standards of Conduct.

Constables, including any elected or appointed constable or deputy constable, who may be engaged to perform services for the Court of Common Pleas of Butler County, Pennsylvania or any of Butler County's Magisterial District Judges, shall adhere to the rules promulgated by the Administrative Office of the Pennsylvania Court governing Constable Policies, Procedures and Standards of Conduct. For NPDES renewal applications in Section I, the Department of Environmental Protection (Department) has made a tentative determination to reissue these permits for 5 years subject to effluent limitations and monitoring and reporting requirements in their current permits, with appropriate and necessary updated requirements to reflect new and changed regulations and other requirements.

For applications for new NPDES permits and renewal applications with major changes in Section II, as well as applications for MS4 Individual Permits and Individual Stormwater Construction Permits in Sections IV and VI, the Department, based upon preliminary reviews, has made tentative determinations of proposed effluent limitations and other terms and conditions for the permit applications. In accordance with 25 Pa. Code § 92a.32(d), the proposed discharge of stormwater associated with construction activities will be managed in accordance with the requirements of 25 Pa. Code Chapter 102. These determinations are published as proposed actions for comments prior to taking final actions.

Unless indicated otherwise, the United States Environmental Protection Agency (EPA) Region III Administrator has waived the right to review or object to proposed NPDES permit actions under the waiver provision in 40 CFR 123.24(d).

Persons wishing to comment on NPDES applications are invited to submit statements to the contact office noted before the application within 30 days from the date of this public notice. Persons wishing to comment on WQM permit applications are invited to submit statements to the office noted before the application within 15 days from the date of this public notice. Comments received within the respective comment periods will be considered in the final determinations regarding the applications. A comment submittal should include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests for public hearings on applications. A public hearing may be held if the responsible office considers the public response significant. If a hearing is scheduled, a notice of the hearing will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. The Department will postpone its final determination until after a public hearing is held.

**PLAN APPROVAL AND OPERATING PERMIT  
APPLICATIONS NEW SOURCES AND  
MODIFICATIONS**

The Department has developed an “integrated” plan approval, State Operating Permit and Title V Operating Permit program. This integrated approach is designed to make the permitting process more efficient for the Department, the regulated community and the public. This approach allows the owner or operator of a facility to complete and submit permitting documents relevant to its application one time, affords an opportunity for public input and provides for sequential issuance of the necessary permits.

The Department received applications for Plan Approvals or Operating Permits from the following facilities.

Copies of these applications, subsequently prepared draft permits, review summaries and other support materials are available for review in the regional office listed before the applications. Persons interested in reviewing the application files should contact the appropriate regional office to schedule appointments.

Persons wishing to receive a copy of a proposed Plan Approval or Operating Permit shall indicate interests to

the Department regional office within 30 days of the date of this notice and shall file protests or comments on a proposed Plan Approval or Operating Permit within 30 days of the Department providing a copy of the proposed documents to persons or within 30 days of its publication in the *Pennsylvania Bulletin*, whichever comes first. Interested persons may also request that hearings be held concerning a proposed Plan Approval or Operating Permit. A comment or protest filed with the Department regional office shall include a concise statement of the objections to the issuance of the Plan Approval or Operating Permit and relevant facts which serve as the basis for the objections. If the Department schedules a hearing, a notice will be published in the *Pennsylvania Bulletin* at least 30 days prior the date of the hearing.

Persons with a disability who wish to comment and require an auxiliary aid, service or other accommodation to participate should contact the regional office listed before the application. TDD users may contact the Department through the Pennsylvania AT&T Relay Service at (800) 654-5984.

Final Plan Approvals and Operating Permits will contain terms and conditions to ensure that the source is constructed and operating in compliance with applicable requirements in 25 Pa. Code Chapters 121—143, the

The project serves to expand the current wet operations at the facility, which were previously exempted from Plan Approval and Operating Permit requirements under Request for Determination of Changes of Minor Significance and Exemption from Plan Approval/Operating Permit (“RFD”) No. 2895, by increasing the quantity and capacities of process tanks (and consequently, production) for, and the strength of the acids used in, the lines.

The (pre-control) potential emission rates of HCl (a hazardous air pollutant (“HAP”)) and HNO<sub>3</sub> from the lines are approximately 4.3 tons/yr and 6.3 tons/yr, respectively. Packed tower wet scrubbers will be installed, with a vendor’s guarantee to achieve a minimum acid gas removal efficiency of 99%, to reduce the acid gas emissions from the facility. Nitric oxide (“NO”) and nitrogen dioxide (“NO<sub>2</sub>”) are also emitted from the HNO<sub>3</sub> line, and the second associated scrubber will also achieve some NO<sub>2</sub> control.

The Plan Approval will include emission concentration restrictions for HCl, HNO<sub>3</sub>, NO, and NO<sub>2</sub> of 0.1 ppmv, 0.1 ppmv, 3.0 ppmv, and 7.0 ppmv, respectively. The Department reserves the right to review these restrictions based on the results of stack testing required under the Plan Approval.

The Plan Approval will include monitoring, recordkeeping, reporting, and work practice requirements designed to keep the facility operating within all applicable air quality requirements.

**39-00099A: Delta Thermo Energy, LLC** (112 W Union Street, Allentown, PA 18102-4912) to issue a plan approval for the construction and operation an energy production facility in the City of Allentown, **Lehigh County**.

In accordance with 25 Pa. Code §§ 127.44(b) and 127.424(b), the Department of Environmental Protection (DEP) intends to issue Plan Approval No. 39-00099A to Delta Thermo Energy A LLC, 112 W Union Street, Allentown, PA 18102-4912, for their plant to be located in the City of Allentown, Lehigh County.

Plan Approval No. 39-00099A is for the construction and operation of an energy production facility. The facility will utilize municipal solid waste (MSW) and sludge from the City of Allentown’s Wastewater Treatment Plant as feedstock to produce a fuel to generate 4 gross megawatts (MW) of electricity for internal use and sale. The facility will be designed with equipment capable of processing an average of 120 tons/day of Municipal Solid Waste (MSW) and 47 tons/day sewage sludge as feedstock. Feedstock for the facility will be prepared onsite from MSW and sludge. The facility will use presorting of the MSW to increase the recovery of recyclables and state-of-the-art technology Resource Recovery System (RRS) to convert feedstock to a renewable clean fuel that will be combusted using an improved Stoker-type combustor to generate steam, which in turn will power a turbine to generate a green, renewable source of electricity.

The facility will consist of the following processes. Receiving & Sorting, Shredding, Feedstock Pit, Five (5) Resource Recovery System Units, Dryer, Combustor (CCC), Boiler, Turbine/Generator and Wastewater Treatment System (WTS).

The facility will emit Clean Air Act-regulated pollutants, including PM<sub>10</sub>, NO<sub>x</sub>, CO, SO<sub>2</sub>, VOC, acid gases and metals. The emission control system consists of the following devices in series: twin cyclones for primary PM removal, selective catalytic reduction (SCR) system with urea injection for NO<sub>x</sub> control, economizer, flue gas recirculation for NO<sub>x</sub> control, fabric filter for control of PM and metals control, wet packed tower with caustic solution recirculation for control of SO<sub>2</sub>, HCl, and HF, 2-stage carbon adsorption system for VOC and mercury control.

After control, the following are estimated emissions from the facility.

The company shall be subject to and comply with 25 Pa. Code § 123.41 for visible emissions. The facility also subject to Best Available Technology (BAT) provisions of 25 Pa. Code §§ 127.1 and 127.12(a)(5). The emissions from the sources will be controlled by the various air pollution control equipment to meet or exceed the BAT requirements for the sources. The Plan Approval and Operating permit will contain additional recordkeeping and operating restrictions designed to keep the facility operating within all applicable air quality requirements.

The Department will include following conditions in the plan approval limiting emissions.

1. Pursuant to the Best Available Technology (BAT) provisions of 25 Pa. Code §§ 127.1 and 127.12(a)(5), the Owner or Operator shall limit the emissions from the facility to the following:

- a. PM—0.39 lb/hr, 1.5 tons/yr. in any 12-month period, rolling monthly.
- b. NO<sub>x</sub>—1.3 lb/hr, 5.0 tons/yr. in any 12-month period, rolling monthly.
- c. HCl—0.13 lb/hr, 0.5 ton/yr. in any 12-month period, rolling monthly.
- d. CO—3.5 lb/hr, 13.4 tons/yr. in any 12-month period, rolling monthly.
- e. VOCs—1.04 lb/hr, 4.0 tons/yr. in any 12-month period, rolling monthly.
- f. SO<sub>x</sub>—1.89 lb/hr, 7.3 tons/yr. in any 12-month period, rolling monthly.
- g. Hg—0.0015 lb/hr, 0.006 ton/yr. in any 12-month period, rolling monthly.
- h. HF—0.12 lb/hr, 0.46 ton/yr. in any 12-month period, rolling monthly.

2. Pursuant to the Best Available Technology (BAT) provisions of 25 Pa. Code §§ 127.1 and 127.12(a)(5), the Owner or Operator shall limit the emissions from the facility to the following:

- a. Lead—0.20 milligrams/dscm at 7% O<sub>2</sub>.
- b. Dioxins/Furans (total mass basis)—13 nanograms/dscm at 7% O<sub>2</sub>
- c. Arsenic and compounds—7.2 ug/dscm at 7% O<sub>2</sub>
- d. Beryllium and compounds—0.2 ug/dscm at 7% O<sub>2</sub>

e. Cadmium and compounds—15.8 ug/dscm at 7% O<sub>2</sub>

f. Hexavalent chromium and compounds—2.3ug/dscm at 7% O<sub>2</sub>

g. Nickel and compounds—25.0 ug/dscm at 7% O<sub>2</sub>

3. Pursuant to the Best Available Technology (BAT) provisions of 25 Pa. Code §§ 127.1 and 127.12(a)(5), the Owner or Operator shall limit the emission of ammonia for selective catalytic reduction (SCR) system exhaust to 5 ppmvd, measured dry volume corrected to 15% oxygen.

4. Pursuant to the Best Available Technology provision of 25 Pa. Code §§ 127.1 and 127.12(a)(5), visible emissions shall not exceed 10 percent opacity for periods aggregating more than 3 minutes in any 60-minute period, except during startup, when visible emissions may not exceed 20 percent opacity for periods aggregating more than 3 minutes in any 60-minute period. Visible emissions may not equal or exceed 30 percent opacity at any time.

5. The storage and handling of the material associated with the aforementioned source(s) shall not at any time result in the emission of fugitive air contaminants in excess of the limitations specified in Section 123.1 of Chapter 123 of the Rules and Regulations of the Department of Environmental Protection.

The Plan Approval and Operating Permit will contain additional, recordkeeping and operating restrictions designed to keep the facility operating within all applicable air quality requirements.

#### MINING ACTIVITY NPDES DRAFT PERMITS

This notice provides information about applications for a new, amended or renewed NPDES permits associated with mining activity (coal or noncoal) permits. The applications concern industrial waste (mining) discharges to surface water and discharges of stormwater associated with mining activities. This notice is provided in accordance with 25 Pa. Code Chapters 91 and 92a and 40 CFR Part 122, implementing provisions of The Clean Streams Law (35 P. S. §§ 691.1—691.1001) and the Federal Clean Water Act (33 U.S.C.A. §§ 1251—1376).

The Department of Environmental Protection (Department) has prepared a draft NPDES permit and made a tentative determination to issue the NPDES permit in conjunction with the associated mining activity permit.

##### *Effluent Limits for Coal Mining Activities*

For coal mining activities, NPDES permits, when issued, will contain effluent limits that are the more stringent of technology-based (BAT) effluent limitations or Water Quality Based Effluent Limits (WQBEL).

The BAT limits for coal mining activities, as provided in 40 CFR Part 434 and 25 Pa. Code Chapters 87—90 are as follows:

In addition, the Department imposes a technology-based aluminum limit of 2.0 mg/l (30 day average) to protect stream uses.

A settleable solids instantaneous maximum limit of 0.5 ml/l applies to: surface runoff (resulting from a precipitation event of less than or equal to a 10-year 24-hour event) from active mining areas; active areas disturbed by coal refuse disposal activities; mined areas backfilled and revegetated; and all other discharges and drainage (resulting from a precipitation event of greater than 1-year 24-hour to less than or equal to a 10-year 24-hour event) from coal refuse disposal piles. Similarly, modified BAT limits apply to iron, manganese and suspended solids in surface runoff, discharges and drainage resulting from these precipitation events and those of greater magnitude in accordance with 25 Pa. Code §§ 87.102, 88.92, 88.187, 88.292, 89.52 and 90.102.

Exceptions to BAT effluent limits may be applicable in accordance with 25 Pa. Code §§ 87.102, 88.92, 88.187, 88.292, 89.52 and 90.102.

*Effluent Limits for Noncoal Mining Activities*

Discharges from noncoal mines located in some geologic settings (for example, in the coal fields) may require additional water quality based effluent limits. If additional effluent limits are needed for an NPDES permit associated with a noncoal mining permit, then the permit description specifies the parameters.

In addition to BAT or WQBEL limits, coal and noncoal NPDES permits establish effluent limitations in the form of implemented Best Management Practices (BMPs) identified in the associated Erosion and Sedimentation Plan, the Reclamation Plan and the NPDES permit application. These BMPs restrict the rates and quantities of associated pollutants from being discharged into surface waters in this Commonwealth.

More restrictive effluent limitations, restrictions on discharge volume or restrictions on the extent of mining that may occur are incorporated into an NPDES permit when necessary for compliance with water quality standards and antidegradation requirements (in accordance with 25 Pa. Code Chapters 91—96).

The procedures for determining the final effluent limits, using a mass-balance equation or model, are found in Technical Guidance Document 362-0600-001, NPDES Program Implementation—Memorandum of Understanding (MOU) Concerning Water Quality Management, NPDES Program Implementation, and Related Matters. Other specific factors to be considered include public comments and Total Maximum Daily Load(s). Additional discharge limitations may apply in the event that unexpected discharges occur.

Discharge rates for surface mining activities are precipitation driven. Discharge rates for proposed discharges associated with underground mining are noted in the permit description.

Persons wishing to comment on an NPDES draft permit should submit a written statement to the Department at the address of the district mining office indicated before each draft permit within 30 days of this public notice. Comments received within the comment period will be considered in the final determinations regarding the NPDES permit applications. Comments must include the name, address and telephone number of the writer and a concise statement to inform the Department of the exact basis of a comment and the relevant facts upon which it is based.

The Department will also accept requests or petitions for a public hearing on NPDES permit applications, as provided in 25 Pa. Code § 92a.82(d). The request or petition for a public hearing shall be filed within 30 days of this public notice and contain the name, address, telephone number and the interest of the party filing the request, and state the reasons why a hearing is warranted. A public hearing may be held if the Department considers the public interest significant. If a hearing is scheduled, a notice of the hearing on the NPDES permit application will be published in the *Pennsylvania Bulletin* and a newspaper of general circulation within the relevant geographical area. When a public hearing is held, the Department will consider comments from the public hearing in the final determination on the NPDES permit application.

*Plan Description:* The approved plan provides an analysis of the flow monitoring data collected after completion of Phase 1 (replacing the sewer system and sewer laterals within the Borough). The plan further outlines the sewage treatment plant size and the collection system for the Beaver Township area to be served. The Knox Borough sewage treatment plant will have a design flow of 0.502 MGD and a permitted organic loading of 1032 lbs/day BOD<sub>5</sub>. For the Wentlings Corner sewer extension within Beaver Township, the plan proposes the installation of 21,000 feet of low pressure sewer main to connect an initial 90 EDUs with grinder pumps. ### Notice of Interim Response Reading Industrial Scrap, Inc. Site Reading City/Muhlenberg Township, Berks County

The Department of Environmental Protection (Department), under the authority of the Hazardous Sites Cleanup Act (HSCA) (35 P. S. §§ 6020.101—6020.1305) has initiated an interim response at Reading Industrial Scrap, Inc. (RISCO). This response will be initiated pursuant to Sections 501(a) and 505(b) of the HSCA (35 P. S. §§ 6020.501(a) and 6020.505(b)).

The RISCO Site is located off Route 61 along Berks Street in the City of Reading and Muhlenberg Township, Berks County. The address of the property is listed as 2001 Centre Avenue, Reading, PA 19605. The RISCO Site can be found on the United States Geological Survey (U.S.G.S.) Elverson Pennsylvania quadrangle map at north 40° 22' 6.3" latitude and west 75° 55' 48.3" longitude. The RISCO Site is located in an industrialized area. The current disposal area covers approximately 3 acres.

Several area major roadways frame the RISCO Site, including Route 61 to the west and Route 222 to the north. A set of railroad tracks lies along the eastern perimeter, a commercial building along the western perimeter, an industrial building along the southern perimeter and a large excavated pit is located inside the northern perimeter of the site.

In the summer of 2004 an initial response by the Department was deemed appropriate to secure the site to prevent direct contact health threats to the public, and promote public safety by preventing unrestricted access to the site. An eight-foot high chain link security fence was constructed around the perimeter of the site and approximately 2,000 tons of contaminated soils and 50 cubic yards of crushed drummed waste containing PCBs were removed and disposed off-site at a permitted waste disposal facility.

In spring 2008, a total of 12 soil borings from a depth of 4' to 40' below ground surface (BGS) were completed on site. In suspected areas of contamination, a total of 13 test pits were excavated from 7' to 25' BGS. An X-ray fluorescence instrument (XRF) was utilized to screen suspect soils and appropriate samples were then collected. The sample results showed that lead and chromium levels had exceeded regulatory standards for non-residential soils, 0—2' deep and iron levels had exceeded regulatory standards for non-residential soils, 2—12' deep. A composite soil sample collected for TCLP purposes showed that the sample did not leach lead from the sample. Site groundwater sampling was also conducted at four monitoring wells and no significant contamination was detected.

Lead and chromium are hazardous wastes as defined under the Solid Waste Management Act, July 7, 1980 (P. L. 380, No. 97, as amended), 35 P. S. §§ 6018.101 et seq., and a hazardous substance as defined under Section 103 of the Hazardous Sites Cleanup Act, Act of 1988, (P. L. 756, No. 108), 35 P. S. § 6020.101 et seq. Lead is an inorganic compound that is listed as a probable carcinogen. Lead is toxic by ingestion and inhalation and chronic cumulative effects of lead are exhibited in the body's nervous system.

The Department proposes an interim response at this site to protect public health and safety or the environment. This determination is based upon the following conditions that exist at the Site: (a) The actual or potential exposure via inhalation, ingestion and dermal contact to hazardous substances; and (b) Public safety issues relative to an open excavation approximately 30 feet in depth.

This response action is not a final remedial response pursuant to Section 504 of HSCA and therefore is not required to meet the cleanup standards that apply to final responses.

The Department will relocate and consolidate all surface-based (0—2 feet) contaminated waste and media in excess of regulatory standards, place the waste in the pit located in the northeastern corner of the site and then cover the waste with two feet of clean fill. Stockpiled soil piles presently located on site may be utilized as clean fill in the bottom and over the top of the pit if sampling determines that the soils meet regulatory standards. The pit will be filled with clean fill and then graded. This will remove the threat for ingestion and inhalation of the lead contamination and therefore be protective of human health as long as the soil cover is maintained. A maintenance plan will be required to provide for inspecting and replacing the soil cover. This will meet a site specific standard of the Land Recycling and Environmental Remediation Standards Act. An Environmental Covenant will be placed on the property to restrict future activities and will include both institutional and engineering controls.

This action will comply with all Applicable or Relevant and Appropriate Requirements (ARARs) and is protective of human health and safety, and the environment. The estimated cost of implementing this alternative is \$57,000. The Department has selected this action because it is protective, cost effective and meets regulatory requirements.

The Department is providing this notice under sections 505(b) and 506(b) of HSCA (35 P. S. Sections 6020.505(b) and 6020.506(b)), and the publication of this notice in the *Pennsylvania Bulletin* starts the administrative record period under HSCA. The Administrative Record which contains information about this site and which supports the Department's decision to perform this action at the site is available for public review and comment.
