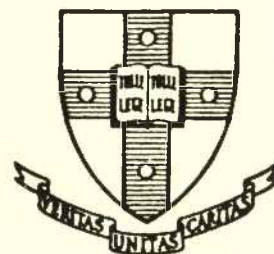

Justice Bruce W. Kauffman has had a distinguished career of service to the people of Pennsylvania as a member of the private bar and the state bench. He received his B.A. in 1956 from the University of Pennsylvania and his LL.B. from the Yale University School of Law, where he was elevated to the Order of the Coif.

Justice Kauffman is a member of the bars of the Commonwealth of Pennsylvania; the State of New Jersey; the U.S. District Court for the Eastern District of Pennsylvania; the U.S. District Court for the District of New Jersey; the U.S. Courts of Appeals for the First, Third, Fourth, and Ninth Circuits; and the U.S. Supreme Court.

A former Senior Partner and Chairman of the Litigation Department of the Philadelphia firm of Dilworth, Paxson, Kalish, Levy and Kauffman, Justice Kauffman was appointed to the Supreme Court of Pennsylvania by Governor Dick Thornburgh on February 6, 1980.

Married and the father of five, Justice Kauffman has participated in the American College of Trial Lawyers; the American Law Institute; the Pennsylvania Constitutional Convention, 1967-68; the Montgomery County Government Study Commission, where he served as chairman in 1973-74; the Committee of Censors for the U.S. District Court for the Eastern District of Pennsylvania, 1976-80; and the Civil Service Commission of Lower Merion Township, 1978-80.
