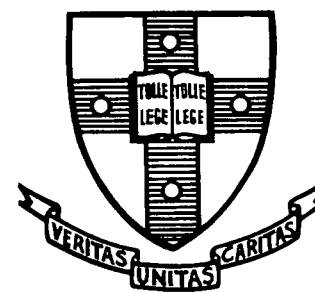

FORUM ON APPELLATE ADVOCACY 1986

Justice Andrew G.T. Moore, II, was born in New Orleans, Louisiana, in 1935. He attended Tulane University, from which he received the degrees of Bachelor of Business Administration in 1958 and Juris Doctor in 1960. Justice Moore then served in the United States Air Force, from 1960 - 63, rising to the rank of Captain. In 1963, he was law clerk to Chief Justice Charles L. Terry, Jr., of the Delaware Supreme Court, after which he joined and became partner in the firm of Connolly, Bove & Lodge, specializing in corporate litigation.

In May, 1982, Justice Moore was appointed by Governor Pierre S. duPont, IV, to the Delaware Supreme Court, and was unanimously confirmed by the State Senate. As a member of the Court, he has authored several important corporate opinions, including *Unocal Corporation v. Mesa Petroleum Company* and *Relvon, Inc. v. MacAndrews & Forbes Holdings, Inc.*, and has been deemed "one of the most influential and controversial figures" of the Court by the New York Times. Justice Moore presently serves as Chairman of the Delaware Judicial Proprieties Committee, as Trustee of the Delaware Bar Foundation, and as a member of the Board of Directors of the American Judicature Society.

John Rogers Carroll was born in Philadelphia, Pennsylvania, in 1928. He received a Bachelor of Arts degree from Saint Joseph's College in 1949 and an LL.B from the University of Pennsylvania Law School in 1952. After serving in the United States Air Force, Judge Advocate General, as First Lieutenant and Captain, Mr. Carroll joined the firm of McBride, von Moschziskor & Bradley, where he later became partner. In 1960, Mr. Carroll began his practice as sole practitioner, and is now the President of the Philadelphia firm of Carroll & Carroll, P.C.

Mr. Carroll appears by special recommendations of Chief Justice Robert N.C. Nix, Jr. and Judge Carol Los Mansmann, United States District Court. A recipient of the Philadelphia Bar Association's Fidelity Award for Service to the Bar, he is presently Chairman of the Philadelphia Bar's Lawyers and Judges Assistance Committee and former Chairman of the Pennsylvania Bar's Drug and Alcohol Committee. His publications include "*The Current Influence of Psychiatric Concepts in the Determination of Criminal Responsibility in Pennsylvania*," co-authored with Dr. Robert Leopold. Mr. Carroll is also a permanent member of the United States Court of Appeals Third Circuit Conference and a participant in several federal forums on appellate advocacy.
